FYI, Maroney's will transport the appliances to the appropriate recycling/reconditioning centers where hazardous materials are removed and parts are salvaged.


ROAD SUPERVISOR'S REPORT--Art Welander

REMINDER: Pushing SNOW out onto City roads and Streets is against State Law. Our concern is your safety.

SPRING ROAD WEIGHT LIMITS: Vehicles traveling on public streets in the City of Grant may not exceed 5 ton gross weight per axle during spring thaw. Spring thaw dates are determined by MN_DOT in our area usually in March or April and into May. Check with me later for those dates. Emergency vehicles and school buses are exempt. It is our City's desire to protect our Streets for the Citizens of Grant.

SNOWPLOWING: Because of the heavy snowfall this year, you may have noticed that the plows are pushing the snow further out on the right of ways (33 ft. from the center of the road) and into the ditches. This obviously will allow for future, possible snowfalls yet to come. Thank you for your patience and support.

CaCl FOR THE YEAR 2001

It's Calcium Chloride time again! The Road Supervisor, Art Welander, will be getting bids in the spring for application this year. The City has made no budget provisions for providing calcium chloride (CaCl) to gravel roads as the product is not needed on all gravel roads, and some residents are not in favor if its application. The city will ensure that the application is done properly.

Talk to your neighbors if you are interested in having CaCl applied, and call Art in April. Forms are available from Welander's or the Grant Web site. The cost will vary depending on the length of road treated and the number of homes contributing. And funds must be deposited before the CaCl application dates.

CaCl would be applied once or twice per summer, immediately after the road has been bladed and then it should be left alone as long as possible. The length of time the chloride remains effective depends on the weather and the amounts of traffic. After CaCl is put onto the roads, the road is not graded for a month, or until residents call the City Road Supervisor to let him know that it is time to grade.

WATERSHEDS

A watershed is a region draining into a river, river system or other body of water. Watersheds may include land-locked basins or lakes, wetlands, streams, lakes, ponds and rivers that all drain through a common outlet if the water levels are high enough. If you have a well, keep reading!

Watershed's are important to recharging the groundwater which feeds your well. Surface water, both quantity and quality, impacts you. For example, erosion, with fast melt runoff or a heavy rain, not only eats away our roads, but carries pollutants and particulates into bodies of water, harming plants, birds, fish, reptiles, and amphibians. If you enjoy nature, the biodiversity found in Grant is directly impacted by watershed issues.

Watershed districts are the political body that manages activities and projects to maintain or improve water quality and flooding related issues. The four watersheds districts found in Grant are based on hydrology, not politics. They are: Brown's Creek, Valley Branch, Rice Creek and Carnelian Marine Watershed. Each district is required to make their projects and plans available to the public in a timely manner.

Watershed projects are funded in several ways, one of which is tax levies on land owners in the specifiic, geographic watershed. Brown's Creek Watershed residents in Grant, Hugo, May Township, Stillwater and Oak Park Heights have all seen a dramatic increase in their tax levy over the past three years. The increase paid for specific projects with tight budget deadlines. Since watershed managers are required to be taxpaying residents in the watershed they represent, they, too, felt the increase. Future tax levels for Brown's Creek residents should be dramatically reduced as the required projects are completed.

Watch for more watershed information and how you can help sustain our natural resources. Specific details on the Brown's Creek projects can be found at the Stillwater and Wildwood Libraries or Grant City Office. Ask for the Brown's Creek Watershed District Plan.

CITY COUNCIL SUMMARY OF ACTIONS--Rick Vanzwol

The following summarizes actions taken by Grant City Council. Please see the minutes for more detailed information on meetings. City Council actions in January 2001:

- 1. After swearing in the new Council members a long list of annual appointments was confirmed.
- 2. The Council decided to appeal the American Tower suit to the Minnesota Supreme Court.
- 3. The Council agreed to hold monthly workshop meeting on Tuesday, the day after the Planning Commission meetings as long as

there are agenda items needing discussion. Agendas will be available on the City website or from the City Clerk.

- 5. Salaries for City employees were increased by 5% for the year 2001 except for the Treasurer and City Clerk who will be considered separately.
- 6. At a workshop meeting January 23 the Council and others discussed options for cablecasting Council meetings.
- 7. At a workshop meeting January 30 the Council and others discussed job descriptions for the Treasurer and City Clerk as well as general issues about the City web site.

City Council Actions in February 2001

- 1. Reappointed Barb Wohlferd as the City Webmaster.
- 2. Appointed Council member Tim Gangnon to form and chair a committee to draft an Emergency Management Plan.
- 3. Set March 13, 2001 for an assessment hearing for the Jocelyn paving project.
- 4. Recessed until February 22 at which time discussed options for improvements to the intersection of Highway 36 and Lake Elmo Avenue.
- 5. All five members of the Council attended the League of Minnesota Cities conference workshop in February.
- 6. At a workshop meeting February 27, discussed job descriptions and salary levels for the Treasurer and City Clerk. Also discussed choices for annual auditor selection.
